

Washington State SAR President's Message - Spring 2019 (2nd Quarter)

This is the presentation I made at the 2019 Washington SAR Annual Meeting after I was sworn in as the new Washington SAR President for 2019–2021:

Thank you for your support! I am honored to have been elected as the new Washington SAR President for 2019–2021. I look forward to serving our state over the next two years.

I want to take a few minutes to share my perspective as I begin in this new position.

First, we need to acknowledge that different Washington SAR members want to participate at different levels.



Some men simply want to be members in order to obtain a certificate to put on the wall, but do not want to attend chapter meetings or engage in any activities. Other members like to attend chapter meetings, but they do not want to participate in any other activities. They like to Meet, Eat and Retreat.

Many members, however, do want to attend meetings and participate in some of our activities, but they do not want to take on leadership positions. Finally, there are a few members who are willing to participate and take on leadership roles.

We need to respect our members' different choices. Many of our members do not participate very much in the SAR, but they are very active in other organizations. Our job is to offer opportunities to our members do more with us, and encourage them to take advantage of those opportunities.

Second, we need to understand the role of the Washington SAR. We are a medium-sized state society. While the National SAR offers many different programs for state societies to do, we cannot participate in all of them. Although we can do a lot, we cannot do everything. Our resources are limited, especially our people.

For these reasons, we need to participate in only the programs our members want to do *and* are willing to lead and participate in. If we try to take on too much, especially programs our members are not interested in, we will burn out our leaders and our active members.

A good example of this is yesterday's Board of Directors' decision to take on Operation Ancestor Search. This National SAR program, which helps wounded US service members do genealogical research, has been around for years, but we did not participate in it. Now we will, because a leader, new Washington SAR Vice President Keith Weissinger, has stepped forward who wants to do it.

Third, the Washington SAR is our eight chapters; they are the lifeblood of our organization. We, the officers and appointees of the state society, are here to support our chapters. I commit myself and our state officers and appointees to do whatever we can to help our chapters in their work. If there is ever anything you believe I can help with, that your chapter officers have not first been able to solve, please call me at 425-301-0808 or e-mail me at craiglawson@comcast.net. My only request: please do not call before 8:00 am or after 8:00 pm, or you (and I) will incur the wrath of Mrs. Lawson!

Thank you once again for your support. I look forward to working with each of you!




Our Ageless Constitution

"The structure has been erected by architects of consummate skill and fidelity; its foundations are solid; its components are beautiful, as well as useful; its arrangements are full of wisdom and order...." - Justice Joseph Story

Justice Story's words pay tribute to the United States Constitution and its Framers. Shortly before the 100th year of the Constitution, in his History of the United States of America written in 1886, historian George Bancroft said:

"The Constitution is to the American people a possession for the ages."

He went on to say:



And two hundred years after the adoption of this singularly-important document, praised by justice Story in one century and Historian Bancroft in the next and said by Sir William Gladstone to be "the most wonderful work ever struck off at a given moment by the brain and purpose of man," the Constitution of 1787 - with its Bill of Rights - remains, yet another century later, a bulwark for liberty, an ageless formula for the government of a free people. In what sense can any document prepared by human hands be said to be ageless? What are the qualities or attributes which give it permanence?

The Qualities of Agelessness

America's Constitution had its roots in the nature, experience, and habits of humankind, in the experience of the American people themselves - their beliefs, customs, and traditions, and in the practical aspects of politics and government. It was based on the experience of the ages. Its provisions were designed in recognition of principles which do not change with time and circumstance, because they are inherent in human nature. "The foundation of every government," said John Adams, "is some principle or passion in the minds of the people." The founding generation, aware of its unique place in the ongoing human struggle for liberty, were willing to risk everything for its attainment. Roger Sherman stated that as government is "instituted for those who live under it ... it ought, therefore, to be so constituted as not to be dangerous to liberty." And the American government was structured with that primary purpose in mind - the protection of the people's liberty. Of their historic role, in framing a government to secure liberty, the Framers believed that the degree of wisdom and foresight brought to the task at hand might well determine whether future generations would live in liberty or tyranny. As President Washington so aptly put it, "the sacred fire of liberty" might depend "on the experiment entrusted to the hands of the American people" That experiment, they hoped, would serve as a beacon of liberty throughout the world. The Framers of America's Constitution were guided by the wisdom of previous generations and the lessons of history for guidance in structuring a government to secure for untold millions in the future the unalienable rights of individuals. As Jefferson wisely observed:

"History, by apprising the people of the past, will enable them to judge of the future; it will avail them of the experience of other times and other nations; it will qualify them as judges of the actions and designs of men; it will enable them to know ambition under every disguise it may assume; and knowing it, to defeat its views."

The Constitution, it has been said, was "not formed upon abstraction," but upon practicality. Its philosophy and principles, among others, incorporated these practical aspects:

- Recognition that **love of liberty** is inherent in the human spirit.
- Recognition of Creator-endowed, unalienable, individual rights.
- Recognition that meaningful liberty is possible only in the company of **order and justice**. In the words of Burke: "Liberty must be limited to be possessed."
- Recognition that in order for a people to be free, they must be **governed by fixed laws** that apply alike to the governed and the government.
- Recognition that the Creator has not preferred one person or group of persons as rulers over the others and that any government, in order to be just, must be from among the great body of the people and by their consent that the **people have a right to self-government.**
- Recognition of human weakness and the human tendency to abuse power; therefore, of the need to divide and to separate the power granted to government; to provide a system of checks and balances; and to make government accountable to people at frequent intervals.



- Recognition that **laws**, to be valid, **must have their basis and limit in natural law** that law which, as Cicero wrote, "is the highest reason, implanted in Nature, which commands what ought to be done and forbids the opposite."
- Recognition of the need for structuring a government of laws, not of men, based on enduring principles and suitable not only to the age in which it is formed, but amendable to different circumstances and times, without sacrificing any of the three great concepts of Order, justice, or Liberty.
- Recognition that **the right to ownership of property** is a right so compelling as to provide a primary reason for individuals to form a government for securing that right.
- Recognition of the need for protecting the individual rights of each citizen, rich or poor, majority or minority, and of not allowing the coercive power of government to be used to do collectively that which the individual could not do without committing a crime.
- Recognition of necessity for incentive and reward as impetus for achievement and growth.
- Recognition of the need for a "Supreme Law of the land" a written constitution which, consistent with its idea of the sovereignty of the people, would provide its own prescribed amendment process, thereby circumventing any potential unconstitutional changes by any of the branches of government without the people's consent.

The Constitution of the United States of America structured a government for what the Founders called a "virtuous people - that is, a people who would be able, as Burke put it, to "put chains on their own appetites" and, without the coercive hand of government, to live peaceably without violating the rights of others. Such a society would need no standing armies to insure internal order, for the moral beliefs, customs, and love for liberty motivating the actions of the people and their representatives in government - the "unwritten" constitution - would be in keeping with their written constitution. George Washington, in a speech to the State Governors, shared his own sense of the deep roots and foundations of the new nation:

"The foundation of our empire was not laid in the gloomy age of ignorance and superstition; but at an epoch when the rights of mankind were better understood and more clearly defined, than at any former period.... the treasures of knowledge, acquired by the labors of philosophers, sages, and legislators, through a long succession of years, are laid open for our use, and their collective wisdom may be happily applied in the establishment of our forms of government."

And Abraham Lincoln, in the mid-1800s, in celebrating the blessings of liberty, challenged Americans to transmit the "political edifice of liberty and equal rights" of their constitutional government to future generations:

"In the great journal of things happening under the sun, we, the American people, find our account running ... We find ourselves in the peaceful possession, of the fairest portion of the earth....We find ourselves under the government of a system of political institutions, conducing more essentially to the ends of civil and religious liberty, than any of which the history of former times tells us. We found ourselves the legal inheritors of these fundamental blessings. We toiled not in the acquirement or establishment of them - They are a legacy bequeathed us, by a once hardy, brave, and patriotic...race of ancestors. Theirs was the task (and nobly they performed it) to possess themselves, and through themselves, us, of this goodly land; and to appear upon its hills and its valleys, a political edifice of liberty and equal rights, 'tis ours only, to transmit these...to the latest generation that fate shall permit the world to know...."

Because it rests on sound philosophical foundations and is rooted in enduring principles, the United States Constitution can, indeed, properly be described as "ageless," for it provides the formula for securing the blessings of liberty, establishing justice, insuring domestic tranquility, promoting the general welfare, and providing for the common defense of a free people who understand its philosophy and principles and who will, with dedication, see that its integrity and vigor are preserved. Justice Joseph Story was quoted in the caption of this essay as attesting to the skill and fidelity of the architects of the Constitution, its solid foundations, the practical aspects of its features, and its wisdom and order. The closing words of his statement, however, were reserved for use here; for in his 1789 remarks, he recognized the "ageless" quality of the magnificent document, and at the same time, issued a grave warning for Americans of all centuries. He concluded his statement with these words:

"...and its defenses are impregnable from without. It has been reared for immortality, if the work of man may justly aspire to such a title. It may, nevertheless, perish in an hour by the folly, or corruption, or negligence of its only keepers, THE PEOPLE. Republics are created by virtue, public spirit, and intelligence of the citizens."

Our ageless constitution can be shared with the world and passed on to generations far distant if its formula is not altered in violation of principle through the neglect of its keepers - WE, THE PEOPLE.

FYI the "ribbon" is the cloth part and the "drape" is the ribbon arranged with a metal ring and pins.

DAR Liaison Committee (Data from the National Site)

The DAR/SAR Membership Award (SAR Handbook Vol. VI)

This award, authorized in 1990, is presented to the DAR State Society that recruits the most new members to SAR. This is a two-track system:

- The first track is using a leveling formula by percentage using the highest percentage with the number of application that have the DAR form finder submitted versus the total number of applications submitted taking into account the State Society total of active members. The DAR State Society that has the highest score of participation as a factor of participation in the program will be awarded certificates and \$300 for 1st place, \$200 for 2nd place, and \$100 for 3rd place to the DAR State Societies.
- The second track is State Societies with the highest raw numbers of approved SAR members using the DAR Finder Form, with \$300 for 1st place, \$200 for 2nd place, and \$100 for 3rd place to the DAR State Societies with the highest number of approved SAR members using the DAR Finder Form.

This is a total of six awards totaling \$1,200. The competition runs from January 1 to December 31 of each year. In order to be counted, a <u>DAR Finder Report Form</u> must be attached to the application packet. The SAR Staff Registrar uses these forms to determine the winner. Applications without the form cannot be counted toward the competition. A separate form must be included with each application received and will be counted toward the contest after the application is approved. Multiple applications cannot be applied to one form.

It is imperative that SAR chapters and societies promote a congenial and harmonious relationship with the <u>National Society Daughters</u> of the <u>American Revolution (DAR)</u> and its chapters and societies for the betterment of both organizations. As potential new SAR members are recruited, one should always ask about their female relatives who could potentially join DAR. In turn, DAR members should be asked to inquire about their male relatives as they recruit new DAR members. When the DAR brings the SAR new members, reward these women with the appropriate SAR medal (i.e. Medal of Appreciation, Martha Washington Medal, and the Daughters of Liberty Medal). SAR applications must include a completed <u>DAR Finder Report Form</u> with that submission in order to qualify for credit.

If your SAR society has such a member and process in place, please share his contact information with the DAR Liaison Committee chairman. Each SAR state-level society should have a DAR Liaison Chairman to spearhead these efforts and should develop its own award guidelines as it relates to rewarding assisting DAR members. It is imperative that the SAR maintains an accurate account of the DAR members who assist the organization in obtaining new members into the SAR and do all that they can to continue and encourage the cooperative relationship that the SAR holds with the DAR.

Minutes of the Annual meeting conducted Olympia Washington April 13, 2019.

The meeting was opened with SAR protocol.

President Anthony Abbott called the meeting to order at 0900 a quorum was present, and the following business was conducted.

President Abbott introduced Treasurer General Davis Wright, VPG Pacific District Gregory Lucas, and Oregon President Kenneth Roberts.

The minutes of the 2018 meeting were accepted as presented.

An election of Officers was conducted with the following results: (See next section)

The following changes to the By-Laws were approved:

Article 7.7 The President shall be the principal executive officer of the Society and, subject to the Board's control, shall supervise and control all the affairs of the Society. He shall preside at Member meetings and Board meetings. To be elected to the office of President, the Member must have served as a Chapter President for a full term in a Chapter in the Washington Society. The President shall not serve in any elected Chapter position during his term.

- 5.1 <u>Composition</u>. The Board of Directors shall be composed of the elected Officers specified in Section 7.1, the Presidents of each Chapter within the Society, the National Trustee, Alternate National Trustee, <u>Color Guard Commander and three Directors-at-large selected by the Board to serve at the pleasure of the Board.</u>
- 6.1 Composition. The By-law and Administrative Procedures Review Committee shall consist of a Chairman named by the Board of Directors who shall have been a state officer, the State Secretary and one other member appointed by the Board of Directors.

6.2 Duties.

(a) Regularly review the Washington SAR Bylaws and recommend amendments to the Board of Directors for approval by the membership at the Annual Members Meeting.

(b) Regularly review the Washington SAR Administrative Procedures and recommend amendments to the Board of Directors.

President Anthony Abbott stated it had been a pleasure to work in a growing society with many talented and capable members.

Treasurers reports a balance of \$24,333.

The Secretary reports current membership is 495 active members. There are 11 members waiting transfers.

The Ladies Auxiliary has been very busy with strong support of the Society.

Color Guard Commander Art Dolan thanked all color guard members and noted that the color guard is the face of the SAR.

Compatriots are reminded to purchase their Challenge coin commemorating the 2021 National Congress.

DAR liaison Chairman encourages all Chapters to reach out to the DAR chapter closest to them and support their programs. The CAR Liaison Chairman encourages all to support the CAR.

Conrad Plyler reports the Society has awarded 32 Bronze JROTC medals. The enhanced JROTC essay contest winner, a cadet from South Kitsap, has been submitted for the National award.

We have a candidate for the National Eagle Scout Award. Stan Wills reports that the Spokane #1 Chapter also recognizes Girl Scouts.

The Naval Sea Cadets highest rank is that of Quartermaster which is equal to Eagle Scout. Alexander Hamilton Chapter recognizes those outstanding Sea Cadets.

The Knight Essay Contest Chairman asked that all Chapters appoint a Knight Essay Contest Chainman.

VPG Gregory Lucas thanked the membership for its support during his term. He encouraged all to attend regional and National meetings.

VTG Davis Wright administered the oath of office from the Officers of the Washington Society of the Sons of the American Revolution.



Trustee's Report Spring Leadership SAR 2019

New member data base: A new member data base is in the works. Combines the other databases and will be tested in 8 states both small and large soon.

Website: Mission Data is the company working on the website upgrade. The goal is to have icons instead of ribbons along the side so you can access via iPhone or Android if you wish. The application module is later.

Budget: The tail end of 2018 was not good for us. We have recouped the losses since, but that does not show up in the 2018 budget. We also added IT personnel and finished the second-floor offices of the building.

Investments: 1.9 million in and 2.1 million out for a minus 214,000 which has since been recouped.

Membership: 34,514 with six states not reconciled. We can't get a good count of membership nor can we use dues income if states are late in reconciliation! 3000 dropped members this year with need to focus on retention.

Foundation: Similar result from the Foundation. The worst December in years for returns on investments. We maintain 60% securities and 40% bond and REITS portfolio.

Logo: A logo competition will be in the magazine soon. A sizable prize cash award is available. The Logo must be 4 colors or less and simple and easily transferrable for printing. The Maltese Cross is our trademark and not going anywhere.

Audit complete and we passed

Congress 2019: Registration may be by 15 May. Hilton Costa Mesa is full, 230 rooms reserved. You must register to go to the Host Reception as it is reserved on a boat.

American Founding Documents: The AFD project was voted as accepted by the Education Committee and the Ad Hoc subcommittee disbanded via vote. The booklets were accepted by the Education Committee with no funding allocated Conflict of Interest forms: Previously Conflict of Interest forms were for NSSAR Officers and Trustees etc. Now the suggestion is for state officers to fill out forms as well. The form is on line I know not where yet.

Rumbaugh Oration: The Chaplain's will now do the verbiage between contestants at congress.

Center for Advancing American Heritage: Moving along swimmingly. The history and content will be portable to schools and individual for home and teacher use. Funds raised July 2017 to September 2018 is \$560,000. Since September \$131,700.

Kings College: The Kings College program is to read all the correspondence of George III that has never been seen by the public. The records reside in boxes in the basement of Kings College. \$165,180 was needed for the scholars to work on this. This was all done by the SAR via private donations no SAR monies spent for this project and the SAR gets the credit and results. Items for the Washington SAR Board of Directors meeting on 28 July 2018.

RECOMMENDED BYLAW AND ADMINISTRATIVE PROCEDUES CHANGES & ADDITIONS:

#1-Bylaw Article 7.7 (under OFFICERS) reads: "President. The President shall be the principal executive officer of the Society and, subject to the Board's control, shall supervise and control all the affairs of the Society. He shall preside at Member meetings and Board meetings. To be elected to the office of President the Member must have served on the Society's Board within three years of election and have served as a Chapter President for a full term. The President shall not serve in any elected Chapter position during his term.

Therefor we move the third sentence be amended to read "To be elected to the office of President, the member must have served as a Washington Society Chapter President for a full term."

Reason, This section of the article eliminated a number of well qualified members from running for President. For this reason, the last nominating had to request the member, Anthony "Tony" Abbott, who has been nominated to be president, become a member of the Board of Directors effective 30 January 2017 to qualify. This would have been true of a number of other qualified men.

#2 - Bylaw Article 5.1 (under 5 BOARD OF DIRECTORS) reads: 5.1 <u>Composition</u>. WAS SAR HISTORIAN-ARCHIVIST REPORT - April 2019 BOD Meeting

I have finished the separation of WASSAR records from the Seattle Chapter records, dumped the junk, organized everything, and catalogued the entire collection of records, documents, and artifacts from 1895-2016. Those records from January 2016 to date are digital images, and as such, present a problem in cataloguing. I have spent portions of 5 years, off-and-on, working on this project. The catalogue and index comprise 163 pages. The records came to me in three separate batches:

- The only known Historian records, dating from 1979-2013, which I catalogued and maintained until 2016 4 file
- The Seattle Historian records, dating from 1895-2014, which turned out to be 75% WASSAR records 4 tubs.
- Those records found and given to Bob O'Neil, dating from the early 1920's to 1964, which also comprised WASSAR and Seattle Chapter records – 5 tubs. These were in a deplorable physical state. Each file year had other years mixed in, the files had been ransacked and mutilated, and nearly all the pertinent signature bearing documents having been lifted and replaced with copies.

I have read, separated, liquidated, organized, catalogued, integrated, and indexed everything. I estimate before my liquidating, there were well over 110,000 sheets of paper. A total of 13 tubs of Historian records have been reduced to 10 tubs. Of which I could liquidate 50 percent more.

During the cataloguing I have extracted Compatriot deaths and obituaries for an album I started keeping in 2013, awards info for the album I started when I was WASSAR Awards Archivist (2009-2016), and photos for an events album I started keeping in 2013.

From the reading of all these records I have obtained a good understanding of the workings of the WASSAR. I will continue to use W-A-S-S-A-R in all of my correspondence, writing, and archiving for the simple reason that during the past 100+ years National has changed, numerous times, the titling ("branding," a term I find offensive), and has always come back to using a state abbreviation with -S-S-A-R. So I advise you to not get too comfortable with, whatever, the new designation is. It probably won't be around for more than a few years.

As I catalogued I became aware of some disturbing discrepancies in the records. We have had several Compatriot "procurements." What has gone missing are:

- 1. Books on genealogy, the Revolution, and Washington State History.
- 2. Two computers.
- 3. Autographed letters and documents, bearing the actual signatures of governors, mayors, congressmen, entertainers, and Federal Government officials.
- 4. Address labeling machine. (and possibly)
- 5. Gavel, made from the wood from George Washington's tree.

Some individual actually cut all the stamps off of the saved envelops going back from about 1940 to the 1920's.

I suggest we spend closer attention to the physical items we are spending money on, and put in place some form of accountability. We now have a searchable archive.

Washington SAR Conference Report (19 April 2019)

Final Report on the Washington SAR Conference held 12-13 April 2019 at the Red Lion Hotel, Olympia, Washington.

Our total income from registrations and donations was \$8,635.00 (\$8,348.00 in 2017). That almost covered all RL costs. Raffles were/are needed to cover all other costs.

Note the higher costs with 23 less people in attendance, other than meals.

The room rent for our guest, Davis Wright, was \$123.32. Other expenses were \$600.69.

The bottom line is a net loss of \$147.89.

I booked our meals at our cost for those attending, not including the gratuity.

We had 59 room nights at the RL Hotel. If we had had 70, we might have had discounts on our meeting room rents, equipment and one free night.

We had 21 (28 in 2017) ladies in attendance. We had 52 men registered (66 in 2017) with a registration income of \$1,060.00, one of them our guest.

I had to confirm meals 3 days prior to the meeting.

The raffle income totaled \$937.00, which the Ladies still have. Donations were \$2,259 (\$1,303 in 2017), so that was a big plus. We can NOT rely on this amount of income each year.

Profit from the musket raffle was \$929.94. Musket was donated in 2017 with an income of \$1,500.00, so we were down the cost of the musket & tickets of \$395.05 or about \$300 less income than in 2017. We should NOT rely on having a musket each year to raffle.

The Board of Directors voted to have NO registration fees, with \$5.00 of our annual state dues being used to cover some of the expenses of the conference. This should also help cover the gratuity and service charges allowing us to keep the meal cost down. But, the planning committee each year must review these costs.

The people at the RL (Red Lion Hotel) were great to work with and fulfilled each of my requests.

All and all, the meetings went very well.

Recommendations:

- If only two hours needed for the Washington SAR Board Meeting, it could be held at 10 a.m. on Friday. The Washington SAR Annual Meeting of Members required three hours on Saturday morning. That would leave Friday and Saturday afternoons for Educational sessions. Also need one hour for the Ladies Auxiliary meeting which could be at the same time as the BOD meeting.
- There should be no outside events for members, but if the conference location has close shopping or tour places, these might be nice for the ladies.

We need to work on better attendance. April may not be the best time to hold the conference, as there are too many other events during the month that members are attending.

THE OLYMPIC HOTEL COMPLAINT

Over the course of numerous years, the WASSAR (we were WASSAR at that time) Board of Managers (now the Directors) held their (then) weekly meetings at various locations in the downtown Seattle business district. Included in these locations were member's business offices, the Seattle Public Library, the American Legion Hall, cafes, restaurants and hotels. Amongst the later was the Olympic Hotel.

In late December 1925 or early January 1926, the Board presented to the hotel a gift of a framed copy of the Declaration of Independence. It was hung in the waiting room of the hotel. But shortly thereafter it was removed and placed in the kitchen.

At their next meeting, upon finding the framed document had been removed from the public eye, the WASSAR Board openly questioned the possibility that the manager had Communist leanings. A fear that was quite prevalent in Seattle at that time. At the following Board meeting of January 23, 1926, it was decided the Board would suspend holding any further meetings in the Olympic Hotel until an explanation in writing was received from hotel management. On January 26th a letter was drafted by one of the Board members, who just happened to be a stockholder in the Olympic, and sent to the Olympic manager. The manager answered with; the Declaration of Independence was not a fitting item to have placed before the public. The WASSAR Board found his response unacceptable. The Board then notified every patriotic society in the State of Washington, sending a copy of the letter drafted by WASSAR and the reply from the Olympic Hotel manager.

The Olympic was never again used as a meeting location nor was it recommended to visiting SAR members. The WASSAR Board also formed a committee to confront the Olympic Hotel Trustees with the WASSAR complaint. This ended the use of the Olympic Hotel and support of it by the Washington State Society.

A Message from our Education Committee Chairman, Brooks Lyles

The requirement to receive the **President General's Education Outreach Streamer** is for the compatriots of a chapter to do a certain number of new Historical Presentations or to present an existing presentation in a new venue or to a new audience. Examples of Historical Presentations would be speaking on a Revolutionary War Battle or Campaign; a significant Personality or Founding Father; a political event or process; life as a soldier (uniforms, weapons, camp life, etc.); life as a colonist (clothing, money, community and religion, etc.); life on the frontier (clothing, Native American relations, living conditions, etc.); life as an indentured servant or as a slave; period flags; period music, etc. It should be left to the chapter Education Team Leader and the State Education Outreach Coordinator to make the call on what constitutes an appropriate presentation. A new venue or audience is just that. If you have a presentation you have done for your chapter and go do it for another chapter, the local DAR Chapter or the Lions Club those are new venues. If you have a class you do for the local 5th Grade Class every year then that is a new audience every year.

The number of presentations required is based on the size of the chapter. The larger the chapter the more presentations required to earn the streamer. The reason is that a larger chapter has more compatriots who can give presentations and therefore more opportunities than the smaller chapters.

The objective of the PG's Program is to recognize those chapters who are taking education outreach to the American people and raising the profile of the SAR in their communities.

Program Streamer Requirements:

- Chapter with less than 41 Members: 3 Presentations
- Chapters with 41 to 80 Members: 4 Presentations
- Chapters with 81 to 120 Members: 5 Presentations
- Chapters with more than 120 Members: 7 Presentations

In order to be considered for streamers Chapters must have their information submitted to the Education Director <u>Colleen Wilson</u> or Education Committee Chairman <u>Brooks Lyles</u>, via email, no later than 10 June annually.

You can download a form for recording and reporting your Education Outreach Events or you can simply send me an email with the pertinent details included. We have a lot of reports already and it is not my intent to add another task to your already crowded days. However, we do want to recognize those chapters that are doing the things that the National Society encourages!

Native Americans in the Revolutionary War


THE ONEIDA TRIBE

The Oneida Tribe was one of the 5 Native American Tribes of the Iroquois League during

the American Rev. The Oneida Tribe was one of the first allies of the Colonist.

The Red on the flag represents the blood spilled before the union of the five nations. The trunk of the tree is white and represents purity while the four roots spread to the four directions of mother earth. The tree is the great tree of the Oneida and bears the three clans of the Oneida tribe, wolf, bear & turtle.

The Bear taught us gentleness and strength. It takes more strength not to raise your hand than it does to strike someone.



The Wolf taught us to use our eyes and be watchful. Strong sense of family.

The tee is topped with an eagle with wings outstretched. The Eagle will warn of any impending danger.

Famous Oneida Chief- Chief Skenandoah (1710-1816) known as "The Deer"

Samuel Kirkland an American Missionary converted Chief Skenandoah to Christianity. The Oneida Tribe supported the colonist and as a result the British burned their villages. Chief Skenandoah fought with General Herkimer at the Battle of Orinskany. In 1777 upon hearing word of the starving men at Valley Forge Chief Skenandoah sent 40 warriors and one Oneida woman (Polly Cooper) to Valley Forge to deliver 700 pounds of

corn for the soldiers. The Mohawks captured Chief Skenandoah in 1780 and held him captive till 1784. He died in 1816 at the age of 110 and is buried at Hamilton College, Clinton N.Y. next to his friend Samuel Kirkland. When Polly Cooper arrived at Valley Forge she taught the men how to cook the corn. If they had eaten the raw corn it would have swelled up in their stomachs and killed them. Martha Washington was so grateful to Polly Cooper that she took her into town and bought her a black shawl. The shawl is still in the possession of the Oneida Tribe and is only put out on display on special occasions.

There is a statue of Polly Cooper, Chief Skenandoah and George Washington at the Natural History Museum for Native Americans in Washington D.C.
